NOTES FOR AUTHORS OF **ORAL** PRESENTATIONS

Speakers are requested to REGISTER for the Conference (Registration Form available on the Conference website www.eubce.com). Please note that your Paper and Presentation files will not be published in the Conference Proceedings having registered for the Conference nor without presenting your paper at the event.

The presentations must be prepared and presented in ENGLISH, the official language of the Conference. As standard technical equipment, a computer (PC) and a beamer (max resolution: 1024*768 pixel) will support your high-quality presentation.

For **computer-driven presentations** please prepare a USB memory stick, DVD or CD-ROM with your Microsoft PowerPoint presentation. Do not compress (e.g. zip) or split your presentation on several media.

The software in use will be Microsoft Windows and PowerPoint (97/2003 compatible, UK standard, save fonts used in your document). Your file should be saved as the respective number of your presentation (i.e. '2AO.1.1.ppt' or '2BO.1.4.ppt'). If your presentation uses digital video or audio files (*.mpg, *.wav) check that they are saved in the same directory as your PowerPoint file and adapt the link if needed.

The file of your presentation should be submitted **online** on the **dedicated presentation submission platform** (link and instructions will be sent by email) or onsite **at the Presenters' Desk**.

An additional computer will be available at the Presenters' Desk (Preview room) to check the correct functionality of your presentation prior to the session. Please label your DVD, CD-ROM or USB stick with your name and the number of your presentation as indicated in the programme.

The **Presenters' Desk** opening hours are as follows:

The files to be published in the **Conference Proceedings** and the Copyright Transfer Agreement Form can be **submitted online** before the Conference, in the user area of the EUBCE website, **or onsite** during the Conference, at the Paper Delivery desk.
